

Dear fellow FSC members,

On Wednesday, September 27th during our monthly board of directors meeting, the board of directors unanimously approved a membership due and range fee increase that will impact the general public, non-voting members, members, and all Folsom Shooting Club approved shooting disciplines.

Our 2016/2017 fiscal year was a fairly lean year due the California Department of Corrections terminating their contact with us. That contract brought in \$150,000.00 + in revenue to our club annually.

Over the last 6 years we have raised fees in most areas but have avoided raising membership dues and range fees for the majority of our membership and FSC shooting disciplines. Public range and competition range fees for voting members and FSC approved clubs have not been increase for as long as I can remember. I believe the \$3.00 public range fee is the original fee since SVSC opened up 25 years ago.

All that being said we also need to be conscious of how our rates impact our membership and customers. Most look at our range fees and believe its small price to pay for such a nice facility, but we also need to think of that family of 5 or 6 that want to enjoy our range as well.

My hopes are that the increase below will allow us to maintain the same level of service we are currently providing to our members, customers, vendors, and allow us to maintain our facility's aging infrastructure. The board of directors are also working on an Environmental Stewardship Program that will also take some funding to complete.

Membership due increase will be implemented immediately, while range fee increases will take effect on January 1st, 2018. Instead of one big increase for membership dues, we will increase \$10 this year, and \$10 next year.

Notes to fee schedule:

1. The fee for active military personnel and Non-Members under the age of 18 is 50% of the posted fee.
2. The fee includes \$2.00 for steel replacement at Diamond Dick's Cowboy Town.
3. The fee for Non-Voting Member applicants who have never been an FSC member, is prorated based on the number of months remaining in the membership year, but not less than 50% of the annual dues.
4. Voting Members may earn a Membership Fee Reduction by completing a Range Improvement Project according to FSC Procedure #2. Advanced approval by the Operations Manager is required. A Range Improvement Project requires 10 hours of work per year, except that projects by Voting Members who are age 60 or more require 5 hours of work per year.
5. The fee includes \$5.00 for steel replacement and the maintenance of Range 6.
